A request was made to move Agenda Item #1 - <u>Approval of Minutes from the Community Advocacy Committee Meeting of February 23, 2021</u>, and Agenda Item #2 - <u>Consider Recommendation to Transformation, Strategic Planning, and Governance Committee for Appointment of Subject Matter Expert to SVMHS Community Advocacy Committee, to later in the meeting. There was no objection to this request.</u>

MOBILE CLINIC UPDATE

Orlando Rodriguez, MD, Medical Director, provided an update on the SVMHS Mobile Clinic. A summary of key highlights is as follows:

• Mission: The SVMHS mobile clinic is dedicated to improving the health of the community by increasing access to care for those living in medically underserved areas, providing preventive and primary care where it is needed.

- Clinic locations: Castroville Elementary School, Walmart North Salinas, Everett Alvarez High School, Greenfield Family Resource Center, MLK Family Resource Center. Locations coming soon are Alisal High School, and King City.
- 678 patients have been served from December 2020 to April 2021.
- Top reasons for visits: sports physicals, hypertension, Type 2 diabetes, medical exam without abnormal findings, elevated blood-pressure reading without diagnosis of hypertension, mixed hyperlipidemia, shortness of breath, rash, prediabetes, and dizziness.
- Community Health Advocates provided food assistance, helped with physical health and with clothing and household goods.
- Philanthropic Support provided by the Sally Hughes Church Foundation, SVMH Service League, Chu Family, and Sunlight Giving:
- Social media and Hispanic marketing are underway to market the services of the mobile health clinic to continue to grow the program and inform people who may need the services.
- Lynette Fitzgerald, Administrative Assistant/Mobile Clinic Program Manager, is the new manager of the program.

There was brief discussion among the Committee regarding the Alisal High School location, immunizations, and COVID vaccines.

BLUE ZONES PROJECT UPDATE

Tiffany DiTullio, Executive Director, Blue Zones Project, presented a Blue Zones Project Update. Key areas reviewed/discussed were as follows:

 - RealAge Test Campaign underway

Blue Zones is using a platform called the Real Age Test which assesses an individual's eating, exercise, and sleep habits, along with family health history, behaviors, and existing conditions. The RealAge Test Campaign is being promoted through direct mail, Hubspot, org/community network, social channels, and Qualtrics. Data is used to help develop strategic implementations to create sustainable impact. After completing the RealAge Test, individuals receive a free personalized experience and health profile with actionable recommendations. The RealAge Test can be completed with or without biometric questions.

There was brief discussion among the Committee regarding the RealAge Test that is provided biennially, and media engagement.

REPORT FROM THE SALINAS VALLEY MEMORIAL HOSPITAL FOUNDATION

Jeff Wardwell, Chief Philanthropy Officer, and Amanda da Graca, Individual Giving Manager, presented a report from the Salinas Valley Memorial Hospital Foundation. A summary of key highlights and areas reviewed are as follows:

Service:

- Patient Assistance Program: Provided assistance for patients most impacted by social determinants of health.
- Family Assistance Program: Provided funding to provide support to families who lost a loved one to COVID at SVMH and are struggling with basic needs.
- Salinas Valley Medical Clinic: Working to integrate assistance programs.
- Monolingual Grief Support: Implemented Spanish language grief support for families who lost a loved one to COVID at SVMH. Funded in partnership with Hospice Giving Foundation.
- In the spirit of serving the community and supporting other local non-profits, the SVMH Foundation has opened up its Community Room for outreach and training needs.

Quality

• Mobile Health Clinic: Using strategic philanthropy to provide access to high quality, healthcare across the community. Donors to the mobile health clinic help to bridge the gap in healthcare access for its most underserved areas.

People

• Work is underway to become a Blue Zones Certified Worksite.

Finance

• The annual grant for FY21 to SVMH is being finalized.

Community

 Current Campaigns for Children's Miracle Network Hospitals are Costco and Bay Federal Credit Union.

Growth

- The Employee Giving Program, Help Us Grow, is a way for employees to give back to the Hospital. Upcoming initiatives / activities are:
 - Campaign Refresh
 - Partners in Excellence
 - Power Hour

There was brief discussion among the Committee and Hospital Leadership regarding the Employee Giving Program, including employee participation, minimum contribution, and potential matching fund. The Foundation Board of Governors has designated a fund for this project.




ADJOURNMENT




