- > Compliance and Ethics best practices and the importance of asking questions.
- > Statements of Economic Interest as of May 27, 2022 Annual Requirements 100% complete.
- ➤ Promoting Interoperability: The Electronic Health Reporting (EHR) Incentive Program "Meaningful Use" attestation requirement is an optional CMS incentive program. Core measures and weighting of results are updated every year intended to demonstrate meaningful use of Certified EHR Technology (CEHRT). SVMH has completed attestation and met State and Federal requirements each year since the beginning of the program (2011)
- ➤ Electronic Clinical Quality Measures (eCQMs) are part of the Promoting Interoperability requirement and were completed timely
- > Action Plans Due Dates were reviewed.

Compliance and Ethics Education Types of Conflict of Interest

The term "conflict of interest" may have different meanings for different individuals. Following are some types for your consideration:

- Your own interests are opposed to the interests of the organization, which may stop you from acting objectively on behalf of SVMHS.
- Your interest in SVMHS success causes you to give false/inaccurate information to a third party.
- You become too sympathetic to the interests of another, causing you to accept their work or their assertions with little or no review.
- Work needing review by someone else is not reviewed because you are the one who performed it and you know it's right.
- Your interest in receiving a bonus impacts your decisions in a way that causes adverse consequences to SVMHS.
- You feel forced to devalue your judgement due to intimidation by someone else.

Sanctions/Exclusions Checking

- Federal and California law enforce penalties against an organization that "arranges or contracts (by employment or otherwise) with an individual or entity that the person knows or should know is excluded from participation in a Federal health care program, for the provision of items or services for which payment may be made under such a program. [42 U.S.C. § 1320a -7a(6); 42]
- "OIG [Office of Inspector General] updates the LEIE [List of Excluded Individuals and Entities] monthly, so screening employees and contractors each month best minimizes potential






Corporate Compliance and Audit Dashboard

PRESS GANEY SURVEY ETHICS SCORE











COMPLIANCE HOTLINE MEDIAN DAYS TO CLOSE ISSUE




COMPLETION OF STAFF EDUCATION BY DUE DATE





