#### 3. BLUE ZONES PROJECT UPDATE

Received an update on the Blue Zones Project from Kendra Howell. Some accomplishments to highlight under food policy are: Double Up Food Bucks, a partnership with Aspire and launches at 4 stores. When customers buy \$10 in produce they receive an additional \$10 to spend on those products. Advocacy for AB605 with support from House Speaker Robert Rivas and Senator Caballero. Established two programs the Monterey County Food System Coalition and the Monterey County Garden Network. For Built Environment, working on safe routes to schools, advocacy for MST's SURF bus and Rapid Transit Project, and Friends of Seaside Parks Association to beautify 25 parks.

#### **COMMITTEE QUESTIONS TO STAFF:**

Vice Chair Hernandez commented that there is a lot of work being done in Monterey County. How do you prioritize the projects? Staff responded that there are specific projects that are being worked on with the cities within the county. An annual blueprint is created to plan the year's projects, with input from the community and Blue Zones subject matter experts.

#### 4. MOBILE CLINIC UPDATE

Dr. Orlando Rodriguez, Medical Director of the Mobile Clinic and Lynette Fitzgerald, Mobile Clinic Manager provided an update to the committee. Since the launch of the clinic, they have seen 13,150 patients, all free medical visits. This year the clinic has been focusing on food insecurity. Qualifying patients are enrolled in the Fresh Produce RX program. The program, in partnership with the Food Bank of Monterey County, delivers fresh produce to patients.

#### **COMMITTEE QUESTIONS TO STAFF:**

Committee member Delgado commented that we should make sure that the County knows of the good work we are doing and explore funding opportunities through them.

#### 5. REPORT FROM THE SALINAS VALLEY HEALTH SERVICE LEAGUE

Received a report from Shannon Graham, Director of Volunteer and Health Career Services regarding three community services Health Explorers, Summer Health Institute, and Medical Adventure Camp. There have been over 300 participants between the three programs. The Hospital has several current employees who have gone through the pipeline of programs.

#### **COMMITTEE QUESTIONS TO STAFF:**

Committee member Delgado gave kudos to the staff at the hospital for inspiring these kids to consider the profession in working in a hospital.

#### 6. REPORT FROM THE SALINAS VALLEY HEALTH FOUNDATION

Received a report from Jeff Wardwell, Chief Philanthropy Officer, and Melissa Gross, Director of Strategic Development regarding the Salinas Valley Health Foundation and their Patient Assistance program. The types of assistance being offered: Perinatal loss cremation, stroller wagon, exercise activity set, aquatic therapy, iPad & Speech App, and Equestrian Therapy.
