

 Government Auditing Standards, issued by the Comptroller General of the United States, and the
 California Code of Regulations, Title 2, Section 1131.2, State Controller's Minimum Audit Requirements for
 California Special Districts
 - communicating significant matters, as defined by professional standards, arising during the audit that are relevant to you
 - when applicable, communicating particular matters required by law or regulation, by agreement with you, or by other requirements applicable to the engagement
- The audit of the financial statements doesn't relieve management or you of your responsibilities.
- The auditor is not responsible for designing procedures for the purpose of identifying other matters to communicate to you.





Elements of an Effective Compliance Program: Policies and Procedures

Our policies guide employees in appropriate conduct, compliance with laws and regulations, and reduce the likelihood of wrongdoing; recognizing that all employees are expected to conduct themselves with integrity.

The Department supports 13 policies ensuring that these are up-to-date and reviewed as required. This quarter, the *Records Retention Policy* was reviewed and approved in partnership with Health Information Management (HIMs).

Elements of an Effective Compliance Program: Compliance Officer

The organization has a Compliance
Officer with authority to manage
the Compliance Program on a dayto-day basis. The Internal Ethics and
Compliance Committee provides
advice and programmatic support
to manage compliance risk and hold
the organization to the highest
standards of ethics and integrity.

The work plan includes compliance with District and other laws, financial and operational risks.

This quarter we supported the organization in 340B compliance, conducted internal audit work, finalized form 700 (statement of economic interests) reporting with 100% completion rate, completed 802 forms (reporting of ceremonial events), and monitored compliance with ethics training. Additionally we participated with Pharmacy and others on the quarterly *Controlled Substances Oversight Committee*.

Elements of an Effective Compliance Program: Education and Training

The organization has effective, ongoing training and establishes open lines of communication.

All new employees receive in-person training in our *Standards of Ethical Business Practices*. Employees are also required to complete annual compliance training.

This quarter, more than 70 new employees received inperson training on the compliance program, False Claims and Stark Acts, Conflicts of Interest policy, Acceptance of Gifts, obligation to prevent fraud, and mechanisms for reporting (including the hotline and the Director's mobile number).

General information provided to new employees during orientation, including information about the Compliance and Audit program and the hotline, was revised.

Elements of an Effective Compliance Program: Reporting

The organization provides an anonymous method for reporting concerns.

People will only report if they trust in anonymity, know they will be protected from retaliation, and believe that their report will lead to change All alerts are reviewed by the Compliance Officer.

Since March 2023, four new alerts were investigated:

- Violation of Policy (anonymous, unsubstantiated)
- General Concern (named, unsubstantiated)
- Falsification of Records (anonymous, unsubstantiated)
- Violence or Threat (named, partially substantiated)

Elements of an Effective Compliance Program: Monitoring and Feedback

The organization performs periodic reviews of its regulatory and other risks, and resolves to correct any issues.

Planning is underway for the risk-based audit and compliance work plan which includes a comprehensive review of the organization's risk universe. Risks will be evaluated based on financial materiality, compliance and operational impact, and leaders' perception of the risks within their purview.

The process includes interviews with leaders to understand the existing control environment and to identify opportunities for collaboration. This may include consulting, review and audit opportunities (internal or cosourced).

Results will be shared with the Committee.

Elements of an Effective Compliance Program: Enforcement

Standards of conduct are enforced and employees, agents, and others are held accountable to these standards.

Matters brought to the attention of the Director of Audit and Compliance are timely and thoroughly reviewed.

This quarter, we partnered with Security,
Operations and the Privacy Office to investigate
and satisfactorily resolve a matter which involved
trespassing and an allegation of a privacy
violation.

Elements of an Effective Compliance Program: Response and Prevention

Detected issues are addressed and deficiencies are corrected.

This quarter, we partnered to research and respond to various inquiries, including admissions criteria, website security, and a possible excluded provider.

All issues are tracked and monitored until appropriate corrective action is taken and the matter is resolved.
