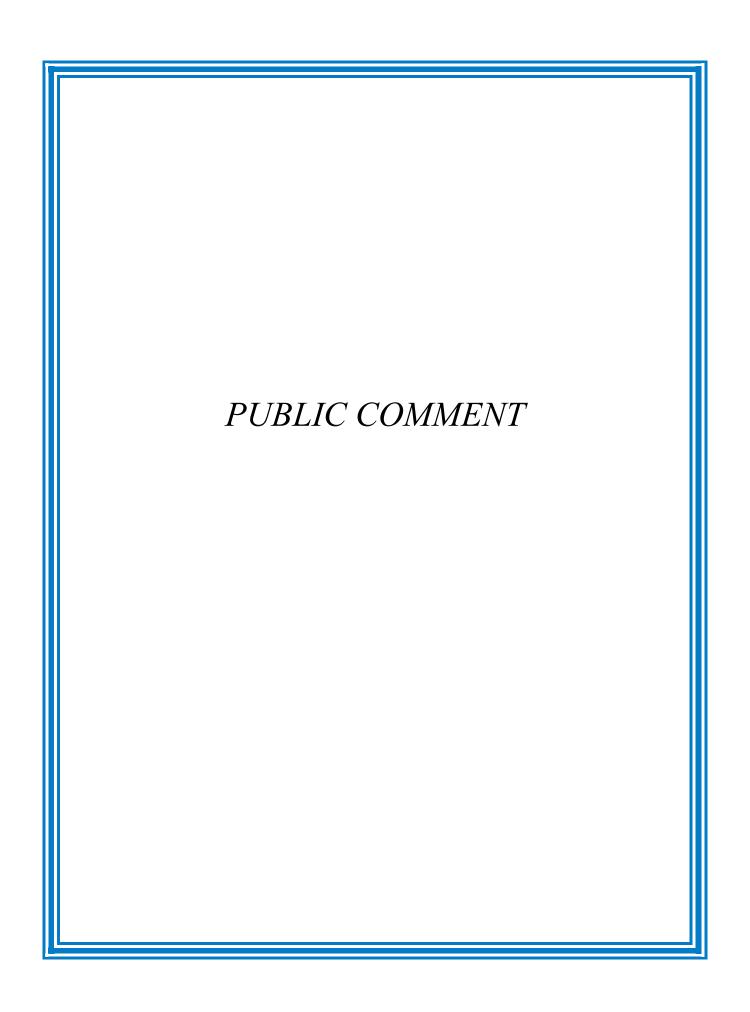

4. BLUE ZONES PROJECT TRANSITION

Dr. Radner provided a background on our involvement and original long-range goals with the Blue Zones Project (BZP); the information provided today is for discussion purposes and will be discussed further in the November Board meeting. Tiffany DiTullio, CAO Community Wellness, reported on the following:

- August 2018 through September 2025 Partnerships timeline.
- People, places and policy focus
- Criteria for certification
- Progress to certification goals 2019-2024
- Community metrics on smoking, diabetes rates/education/screening/awareness, high blood pressure, access to healthy food, high cholesterol, 5+ vegetable servings, exercise and engagement.
- Community well-being and metrics
- Current services & expenses
- Sustainability options with cost comparisons and recommendations including transition plan options and maintaining integrity of the program

A full report was provided in the packet.

COMMITTEE MEMBER DISCUSSION: Julie Edgcomb endorsed considering a long-term program. Dr. Gonzalez asked about environmental assessment, specifically related to pesticides. It was noted that environmental assessment is a part of BZP but not this specific factor. Victor Rey endorsed exploring options. There are currently two BZP offices; the intent is to reduce to one location. Financial sponsors include SVH, CHOMP and Taylor Farms; planning has been transparent and they are aware options are being considered.

5. COMMUNITY FUNDING UPDATE

Informational only. A full report was provided in the packet.

COMMITTEE MEMBER DISCUSSION: Lynette and Mobile Clinic team made the BZP flu clinic possible; 173 vaccinations were provided. Celina Medina, FNP, is doing amazing with the Mobile Clinic. Mobile Clinic metrics are now part of the dashboard.

6. SALINAS VALLEY HEALTH FOUNDATION REPORT

Melissa Gross, Director Strategic Development, and Jeff Wardwell, Chief Philanthropy Officer, reported on the following:

- FY25 YTD Released Funds
- Funds Granted FY20-FYF25
- Partners in Excellence Program: Guidelines which include eligibility, the process for application, executive leader involvement, budget/cost estimate. application review, and Board of Governors review. Once funded, progress reports are required. Grants are reviewed twice per year (current cycle ends November), Examples of approved projects were provided.

Salinas Valley Health has a firm, seven decades long commitment to serve our diverse community with every individual and each family deserving of respect and access to quality medical care, regardless of immigration status.

We understand that many in our community have concerns about accessing healthcare services due to the current climate surrounding immigration enforcement. We want to reassure our patients that their health and well-being remain our top priorities. We strictly adhere to laws governing privacy practices and are committed to protecting patient confidentiality.

We stand strong and united with other organizations advocating for the rights and dignity of all individuals, and we will closely monitor federal developments that may impact our local community. Our doors are open, and we encourage anyone in need of medical care to seek it without fear. Together, we can foster a healthier community, ensuring that everyone has access to the care they deserve.

Immigration Policy – ICE enforcement

1. Respond Courteously and Professionally

- Politely inform the officer that you are not authorized to assist but will immediately contact your supervisor.
- Ask the officer to wait while you call the nursing supervisor.

2. Contact the Nursing Supervisor at Extension 5771

The Nursing Supervisor will gather as much information as possible, including:

- Date, time, and location of the officer's arrival
- Document name of the ICE agent with identification information (Badge Number) if available
- Nature of the investigation
- Whether ICE has legal documentation to inquire about a specific individual
- Whether Salinas Valley Health Legal Counsel or the Administrator on Call needs to be contacted
- Interactions with ICE agents must be documented in the facilities incident management system.

Immigration Policy – ICE enforcement (cont.)

3. For Administrators – ICE Protocol

California and federal health information privacy laws prohibit hospitals, physicians, and other healthcare providers from disclosing patient information to ICE officers unless:

- The patient signs a legally compliant authorization for the release of information form.
- For medical information requests, the officer provides a subpoena, search warrant, or court order issued to ICE.
- For physical access requests, the officer provides a judicial warrant signed by a U.S. District Court judge or magistrate.
- For critically ill patients The ICE agent shall be asked to confer with the attending physician to
 ensure the patient meets their criteria for safe release.
- In the event a patient is removed from the facility, the facts associated with the patients removal must be documented in the patient's medical record

Staff are asked to refrain from engaging with ICE officials except as outlined above.

We recognize that guidance may continue to evolve, and our response may be updated accordingly.

Staff Guidance – ICE enforcement

- Staff are not asked to determine validity of warrant/court order
- Any enforcement actions regarding employee's is to be referred to HR
- Always attempt to negotiate the safest disposition for patients
 - Involve attending physician in discussion with ICE Agent
- Do not hinder access if agents are insistent
- Clearly document events in patients record and incident occurrence system
- Notify risk management
- Keep "Red Cards" available at all entrances
- Clinic Process aligns with hospital policy







Donations were received from 63 individual Salinas Valley Health staff members and 1 department, with in-kind support from the Foundation.



Patient Assistance - Impact in Action

"Thank you for helping my family. I didn't have diapers at home for my baby and everything is so expensive. My husband can't work because of his treatment. You are angels."

Patient was unable to afford her co-pay for a wound vacuum that was ordered after a surgical procedure, and had planned to "just not pick it up" in order to avoid the expense. Instead, her social worker utilized the Patient Assistance Program and the co-pay of nearly \$400 was paid directly to the equipment vendor.

A 5-month-old pediatrics patient needed home nebulizer treatments in order to be safely discharged, but the mother wasn't able to afford the out-of-pocket costs for the device. Her Case Manager applied for Patient Assistance, and the baby was able to be discharged as planned.

Gas and grocery support was provided to a 40 year old mother of 2 with metastatic cancer. The patient doesn't qualify to receive disability benefits, has no source of income, and her 19 year old daughter isn't able to work because she is her mother's caregiver.
