


The Community Advocacy Committee meets quarterly and the next meeting is scheduled for **November 12, 2025**.

1. CALL TO ORDER/ROLL CALL

A quorum was present and Chair Rolando Cabrera, M.D., called the meeting to order at 12:02 p.m. at the Heart Center Teleconference Room.

2. PUBLIC COMMENT

None

3. APPROVE MINUTES OF THE COMMUNITY ADVOCACY COMMITTEE NOVEMBER 13, 2024

Approve the minutes of the November 13, 2024 Community Advocacy Committee meeting. The information was included in the Committee packet.

4. SVH MISSION / IMMIGRATION

Dr. Radner reported on the need to create internal and external facing messages. Clement Miller, COO, provided a report on the SVH Immigration Policy for ICE enforcement including:

- Communication from Dr. Radner on January 24, 2025 addressing community concerns surrounding immigration enforcement.
- Steps to take if approached by ICE officials including responding courteously/professionally, contacting the Nursing Supervisor, California/Federal health information privacy laws and staff guidance on what to do if approached which includes valid warrant/court order, staff role, referral/notification process, and documentation through incident occurrence system.
- SVH Clinics align with hospital policy.
- Red Cards will be available at all entrances.

A full report was included in the packet.

Karina Rusk, Director Public Relations, provided a report on Immigration Policy External Messaging including:

- Messaging is non-political, Mission driven, consistent messaging of healthcare for all, collaborative with other hospitals.
- Review of the Monterey County Hospital Unite Letter to the Community in English and Spanish.
- Media outreach which produced media coverage. Dr. Gonzalez was interviewed. Spanish audiences were prioritized using trusted journalists. The Monterey Herald ran the entire collaborative letter. An immigration community issues working group has been established to continue to monitor the situation.

COMMITTEE MEMBER DISCUSSION: There have been no incidents to date. The messaging is the same for Clinics and the Mobile Clinic. Has the average daily census changed? No, census remains high. Dr. Radner stated he knows of two patients who returned to Mexico for their care and one patient who is afraid to access care. Dr. Gonzalez has gotten feedback from staff that are grateful the message is being shared with the community.

5. COMMUNITY PILLAR UPDATE

Tiffany DiTullio, Vice President, Partner & Community Relations, reported on the Community Pillar FY2025 Goals and progress as follows:

- Increase community engagement through individual district zone specific events achieved by:
 - o Diversified community outreach events in each of the five District zones
 - o Community health and service line promotion prioritized
 - Measured by event hosting or participation

Threshold completed for Zones 2 and 5.

- Allocation of Community Benefit funding achieved by:
 - o Development of a Community Funding dashboard
 - o Include District funding distribution
 - o Outreach to underrepresented communities to encourage aligned funding request

Threshold exceeded for both North and South Counties.

Upcoming Community Health Days including Mobile Clinic and flu shots:

- Thursday, March 6, Noon-3pm, MLK Family Resource Center
- Sunday, March 30, 10am-2pm, Marina Farmers' Market
- Sunday, April 27, 1-5pm, Castroville Day of the Child

A full report was included in the packet.

COMMITTEE MEMBER DISCUSSION: Dr. Gonzalez asked if we could partner with Hospice Giving Foundation to increase attendance for events focused on DNR and POLST.

6. SALINAS VALLEY HEALTH FOUNDATION REPORT

Melissa Gross, Director Strategic Development, and Jeff Wardwell, Chief Philanthropy Officer, reported on the following for FY25 Q2 YTD:

- 349 unique lives, 442 encounters, \$63,108 in support
- Patient Assistance totals by type of assistance, zip code, access point, payor source, and expenses/encounters month over month. Will be working with Clinic to increase access to assistance.
- CMN Pediatric Medical Needs Assistance by type of assistance, unique patients/payor source, county, zip code, and projects recently funded.

Additionally reported:

- Adopt a Patient Family Program update. Staff directly supports patient in the holidays.
- Patient Assistance feedback. Patient impact examples were shared.
- 2025 Local CMN Champion, Niko, age 12, who is a lifelong patient of SVH and an experienced Asthma Camper. Niko's family credits SVH with not only helping to diagnose and treat his medical conditions, but also with educating and empowering him to manage his health and live a full, active life.

A full report was included in the packet.

COMMITTEE MEMBER DISCUSSION: How does the hospital contribute to the Adopt a Patient Family Program? This program is staff driven, but the Foundation can include the Board this year. Dr. Cabrera asked for information on Foundation reserves, Board membership, administrative structure, major donors, grant writing, funding for the last five years and plans for the future. The Foundation was asked to provide an in-depth report at the next meeting.

7. CLOSED SESSION

Chair Dr. Cabrera announced that the item to be discussed in Closed Session is *Report Involving Trade Secret: Trade Secret, Strategic Planning, Proposed New Programs and Services.* The meeting recessed into Closed Session under the Closed Session protocol at 12:40 p.m.

8. RECONVENE OPEN SESSION/REPORT ON CLOSED SESSION

The Committee reconvened Open Session at 12:56 p.m., Chair Dr. Cabrera reported that in Closed Session, the Committee received a *Report Involving Trade Secret: Trade Secret, Strategic Planning, Proposed New Programs and Services*. No action was taken in Closed Session.

9. ADJOURNMENT

There being no other business, the meeting adjourned at 12:57p.m. The Community Advocacy Committee Meeting meets quarterly and the next meeting is scheduled for **May 14, 2025 at 12:00 p.m**.



What Qualifies as Community Benefit?



What Counts

A program or activity that responds to a demonstrated health-related community need and seeks to achieve at least one community benefit objective:

- 1. Improve access to health services
- 2. Enhance public health
- 3. Advance knowledge through education or research
- 4. Relieve or reduce a health burden of government or other tax-exempt organization

What Does NOT Count

- 1. Benefits the organization more than the community
- 2. Provided primarily for marketing purposes
- 3. Provided by another entity or individual
- 4. Restricted to employees or medical staff
- 5. Represents a normal "cost of doing business" or the current standard of care













Patient Assistance & Pediatric Medical Needs Grants






FY25 Year End


